ENTITY'S PURPOSE OR MISSION:

The charitable aims of the society are to:

- stimulate and sustain interest in Pātaka Museum of Arts and Culture ('Pātaka').
- to extend its influence throughout the community, being activities, which will take place wholly or principally within New Zealand, including:
 - the organisation and sponsorship of a biennial Arts Awards designed to nurture and give public exposure to local artistic talent.
 - the provision and funding of an annual 'Artist in Residence' programme.
 - the staging of a music concert series each winter, to expose local musical talent to a wider audience.
 - supporting Pātaka staff by providing logistical support for events such as exhibition openings and concerts and in the purchase of items to enhance the visitor experience.

ENTITY STRUCTURE:

Friends is an Incorporated Society and registered Charitable Trust. Governance is by a Management Committee elected at the Annual General Meeting each year. All are volunteers.

Officers of Friends comprise: Co-President (2); Secretary; and Treasurer

In addition, the Management Committee comprises not less than four, but not more than ten other members.

ARTIST IN RESIDENCE - SEE NOTE 3

As winner of the 2022 Art Awards, Roger Hayman was offered residency at Pātaka Arts and Museum in January 2023.

DONATIONS MADE - SEE NOTE 4

In accordance with our aim to support Pātaka financially when requested, a donation of \$5,000 has been made to support the printing of the Pātaka 25th Anniversary book. We also donated various prizes to support Pātaka events.

FRIENDS OF PĀTAKA CONTENT MANAGEMENT SYSTEM (CMS) - SEE NOTE 5

In 2020 Friends developed a website and document storage system facility by engaging volunteer students from the Bachelor of Technology at Whitireia Polytechnic. Friends have continued to develop the CMS in 2023 and have adopted in conjunction a Facebook page and Instagram. Friends have also adopted Xero as their accounting platform.

MUSIC SERIES 2023 - SEE NOTE 6

The Winter Music Concert Series is held July/August of each year. In 2023, the series involved four concerts of one hour duration by local musicians including students. Admission is free for members. Non-members are charged \$5 per concert. Musicians are paid a fee of \$400.

EVENTS AND WORSHOPS - SEE NOTE 7

In accordance with our objective to stimulate and sustain interest in Pātaka, Friends have organized and supported a number of events including workshops, support of Pātaka's 25th anniversary events, hosting of other friends groups and a history tour.

ART AWARDS - SEE NOTE 8

The Friends of Pātaka Art Awards is now held biennially. There was no Art Awards in 2023.

RELATED PARTY TRANSACTIONS

There are no related party transactions.

VOLUNTEER HOURS

Friends regularly volunteer to support openings and large scale events at Pātaka – for example we hosted Friends of Te Papa and our members to a gallery talk by Te Papa curator Dougal Austin and assisted with refreshments at several large openings. We hosted Mahara Gallery Friends and our members to a talk given by chief curator Ioana Gordon-Smith to support the Naadhobi exhibition. We help conduct the annual National Museums Survey on behalf of Pātaka. This is a week of volunteer hours.

Friends of Pātaka Incorporated ('Friends') is permitted by law to apply PBE SFR-C (NFP) Public Benefit Entity Simple Format Reporting - Cash (Not-For-Profit) and has elected to do so. All transactions are reported in the Statement of Receipts and Payments and related Notes to the Performance Report on a cash basis.

GOODS AND SERVICES TAX (GST)

Friends of Pātaka Incorporated ('Friends') is not registered for GST. Therefore amounts recorded in the Performance Report are inclusive of GST (if any).

INCOME TAX

The entity is wholly exempt from Income Tax having fully complied with all statutory provisions for these exemptions.

BANK ACCOUNTS

Bank Accounts and Cash in the statement of Cash Flows comprise cash balances and bank balances (including short-term deposits) with original maturities of 90 days or less.

APPROVED DONEE ORGANISATION

The entity is an Approved Donee Organisation for the purposes of sections LD 1, DB 41 and DV 12 of the Income Tax Act 2007.

FIXED ASSETS

Banners and corflutes were bought for the 2021 Arts Trail at a cost of \$2,573 and expensed in the year purchased..

There have been no changes in accounting policies during the financial year (last year – nil).
